The tendering authority at its discretion may verify original documents.

2. Part-II is to be submitted in a sealed cover & shall consist of the financial bid only.
3. Last date & time for receiving application is 11/10/2007 up to 14.00 hrs. from the office of the Tendering Authority. Copies of Tender documents and other specification and terms and condition can be had from the office of the Tendering Authority on payment by Cash/Pay Order/Banker's Cheque/Demand Draft till 15/10/2007 up to 14.00hrs. The Tender documents are not transferable and cost of the Tender document is not refundable /adjustable under any circumstances.
4. Earnest money @ 2% of the quoted amount is to be submitted in the form as specified below. Earnest money should be given within a sealed envelop inside the envelope of Part-II. During opening of Part-II, at first the value of the Earnest money will be verified with respect to the tendered amount. If the same is not in line with the provision of NIT, the tender will be considered informal and be cancelled.
5. Both Part-I and Part-II are to be properly sealed in separate cover with superscription of Part No. and brief contents.
